## Dallas Center North/Adel North Broadband Expansion

### Minburn Telephone Company – OCIO NOFA #006 Census Block Eligibility Challenge Dallas Center North/Adel North

Minburn Telephone Company (Minburn) respectfully requests to challenge the census blocks included in this filing, which are also included in its NOFA #006 OCIO Broadband Grant, Dallas Center North/Adel North. The identified census blocks are currently being reflected as served on the Broadband Availability Map V4; however, it has been determined through the completion of thorough due diligence by Minburn's staff and supported by consumers in the specified areas that the claimed level of broadband service is widely overstated by the service providers.

Minburn is challenging each of the service providers claiming to provide broadband in the census blocks reflected in this challenge. In addition to Bits of Technology Wireless Internet, CenturyLink is claiming to provide service in some of the challenged census blocks; however, the claimed coverage is less than 15% of the census block on average. Mediacom and Windstream are also claiming to cover less than 8% and 30%, respectively. As reflected in the residential affidavits obtained, the service offered by each provider is not at the speeds being claimed.

The following supporting documentation for this challenge has been broken out into five sections: 1) Dallas County Information; 2) Dallas Center North/Adel North Research; 3) Bits of Technology Wireless Internet Challenge; 4) Residential Affidavits; and 5) Other Supporting Documentation.

#### **Dallas County Information**

Information found in this section was provided by HR Green and the Greater Des Moines Partnership. The images depict the results from a May 2021 survey of residents and businesses throughout Central Iowa. The survey responses presented here highlight the current gaps in broadband availability, speed/performance, reliability, and affordability in Dallas County.

#### Dallas Center North/Adel North Research

This section contains information that was provided by CheckPoint Solutions via data collected from Minburn's crowd sourcing tool. The CheckPoint Solutions platform is used by providers to mine data on current broadband availability such as speed tests of existing connections as well as gathers demand generation of interest. The research presented is a graphical representation of the speed tests completed in the challenge area that supports the challenge form.

#### **Bits of Technology Wireless Internet Challenge**

This narrative represents an analysis conducted within the past 60 days as to the current service providers, specifically Bits of Technology Wireless Internet (BTWI), and their current marketing and service offerings. Findings offer technical arguments to explain why their current offerings are overstated.

#### **Residential Affidavits**

The residential affidavits in this section are signed and notarized by consumers in the challenge areas stating broadband service is unable to be provided at the speeds being claimed by the current providers which include, but are not limited to, BTWI, Centurylink, Mediacom and Windstream.



#### **Other Supporting Documentation**



As shown, the postcard message offers **UP TO 30 Mbps**; however, this speed is significantly less than what BTWI has claimed it is able to deliver per the Broadband Availability Map V4.





#### SECTION 3) Bits of Technology Wireless Internet, LLC Challenge

Bits of Technology Wireless Internet, LLC (BTWI) is listed as having advertised throughputs of 100/50Mbps (downlink/uplink, respectively) throughout the Census Blocks (CBs) that Minburn Telephone Company (Minburn) is presenting within this challenge, as shown below.



Through field validation at common Bouton site, Minburn documented that BTWI is utilizing equipment manufactured by Ubiquiti Networks (Ubiquiti) in the unlicensed 2.4GHz and 5.2/5.8GHz frequency bands, as well as the lightly-licensed, Part 90 frequency band.

For its unlicensed operations BTWI is utilizing Ubiquiti's LTU and Rocket 2AC Prism equipment. The manufacturer documentation for the Ubiquiti LTU equipment indicates for the maximum channel width of 50MHz is capable of achieving a maximum throughput of 600Mbps (aggregate, uplink and downlink). With a maximum of 600Mbps throughput, at the 100/50Mbps advertised speed tiers, if dedicated, BTWI would only be capable of servicing four to six subscribers<sup>1</sup> per LTU sector, assuming BTWI is able to secure an unencumbered 50MHz wide channel with the unlicensed 5GHz band.

The manufacturer documentation for the Ubiquiti Rocket 2AC Prism equipment indicates for the maximum channel width of 40MHz is capable of achieving a maximum throughput of 330Mbps (aggregate, uplink and downlink). With a maximum of 330Mbps throughput, at the 100/50Mbps advertised speed tiers, if dedicated, BTWI would only be capable of servicing two to three subscribers<sup>2</sup>

per Rocket 2AC Prism sector, assuming BTWI is able to secure an unencumbered 50MHz wide channel with the unlicensed 5GHz band.

BTWI is also utilizing its Nationwide Nonexclusive, Part 90 license (3650-3700MHz), under Call Sign WQOU655, to deliver service to the CBs that Minburn is challenging. In 2015, the FCC released its Part 96 ruleset (3550-3700MHz), which encapsulated the spectrum formerly licensed under its Part 90 ruleset. The FCC allowed existing operators to continue operating their Part 90 networks through October 17, 2020, or through the expiration of their license terms, whichever is longer. BTWI's license under Call Sign WQOU655 has a license expiration of February 3<sup>rd</sup>, 2022, at which time BTWI must transition its operations to follow the Part 96 ruleset or cease operations. Per the FCC's Universal Licensing System (ULS), BTWI has twelve site locations<sup>3</sup> registered and each site location indicates that it utilizes equipment with the FCC ID of SWX-M365. FCC ID of SWX-M365 is Ubiquiti Networks (Ubiquiti) M365 product line and it is worth noting that the Ubiquiti's M365 product line has not received FCC type-acceptance for the operation under the Part 96 ruleset. The lack of FCC type-acceptance will require BTWI prior to February 3<sup>rd</sup>, 2022, to replace its Part 90 network with a Part 96-compliant manufacturer, equipment capable of operating on different frequency band or cease operations altogether.

With its unlicensed operations, its Part 90 license expiring on February 3<sup>rd</sup>, 2022, and the uncertainty created by its selected manufacturer, Minburn questions BTWI's viability to deliver a sustained, consistent 100/50Mbps service to the majority of the locations in the indicated rural CBs utilizing typical customer configurations and site loading considerations.
