**Work:**

**During the COVID-19 pandemic, many businesses sent employees to work from home. Since then, some employers have either kept that model to reduce overhead, or let employees utilize a hybrid schedule. This requires a reliable and strong broadband connection. The job search for both employees and employers is done via the internet and often times a first interview is done virtually saving time and money for both the business and potential employee. This requires a stable connection. Also, a county-wide broadband connection is enticing to people as they are looking to move to the area adding value to their homes and providing the ability to work for any business worldwide, eliminating barriers to job opportunities.**

This subfactor takes into consideration whether Broadband investments in the proposed Geographic Area of Concern will help facilitate educational activities. Such education activities may be to acquire knowledge and/or skills, undertaken as part of a person's participation in school, an academic program, extracurricular program, social-emotional development program for students or youths, internship, or professional development program, or in another educational environment.

**Education:**

**During the pandemic, schools switched from in-person to virtual learning. This has progressed to now schools have issued devices to each student and they can learn from home during inclement weather. Even if children are not enrolled in their local educational facility, there is the option of a home-based online education. This requires a robust and reliable broadband connection. Many students and adults can attend college classes or take additional coursework online. This is also nearly impossible without a reliable connection.**

This subfactor takes into consideration whether Broadband investments in the proposed Geographic Area of Concern will help facilitate health monitoring services to monitor an individual's health, including with respect to either physical or behavioral health.

**Health Monitoring:**

While there is a local hospital in Winneshiek County with specialized healthcare and multiple clinics, some specialty services are a considerable distance away. Virtual appointments and tele-health appointments are on the rise and will continue to expand. Mental health is one the most important aspects of virtual appointments. Patients can schedule and see a professional in the comfort of their own home. A stable, reliable, robust broadband network will help our residents access these services.

Winneshiek County is an agriculture-based county in northeast Iowa and extremely rural. Broadband networks are difficult to build as the distance between locations is several miles resulting in few consumers per mile. Also in rural areas, the drops are long (for example - long driveways to farmsteads) as opposed to urban builds with short drops. Many sites are outlying of the fiber route and costly to build. This should not hinder a customer getting service.

**Topography**

Winneshiek County is in the Driftless Region of northeast Iowa. Many creeks and valleys run through this area posing for difficult and costly fiber installation. Additionally, rocky terrain adds expense to a fiber network with boring, protecting the fiber in conduit, etc.

**Demographics**

It is imperative that consumer education and awareness is at the forefront while providing the best broadband to Winneshiek County. There are options for low-income residents so they can have this essential service available to them. It is important to teach consumers how to utilize and maximize their connection and get the best experience possible.
