Winneshiek County Supervisors:

I am writing in support of Winneshiek County being classified as a Broadband Intervention Zone for areas in the County that are unserved or underserved with internet service.

I live in Bluffton Township, along the bluffs of the Upper Iowa River. In my extended rural neighborhood, there are limited options for high-speed, reliable internet. Residents rely on satellite options with low success, often running out of data well before the month's end or experiencing disruptions in service due to weather conditions.

In my elected position of Winneshiek County Sheriff, I am responsible for the safety and security, and the protection of the constitutional rights, of the citizens of this county. In today's electronic/digital age, I am unavailable to them when at home due to low and/or absent service. It is common for me to have to pull service from my Sheriff's truck hotspot, and use the hotspots through our AT&T cell phones – the only carrier that works in our valley. My wife is the Public Information Officer for Winneshiek Medical Center, which is our county's hospital. Her role, and the fallout if she is unable to perform her duties in emergency situations, faces the same challenges as mine.

Additionally, the pandemic years highlighted the shortfall in internet service, as our children had to employ alternate means to complete their online school work, which regularly meant going to a classmate's house or our church to gain internet access. Beyond the pandemic, most classroom assignments, up to entire courses, are provided online. Lack of reliable service hinders the educational opportunities for our children. Also post pandemic, many adults have jobs that have transitioned from office buildings to working remotely from home. People working remotely need reliable internet service to provide for their families.

Mabel Cooperative Telephone services exist on the fringes of the Bluffton river valley. If Winneshiek County, and specifically the Bluffton area, is classified as a Broadband Intervention Zone and service is extended into the un/underserved regions, the people of Winneshiek County will be better served by those who are charged with their protection.

Winneshiek County Board of Supervisors,

I am writing in support of Winneshiek County being designated as a Broadband Intervention Zone.

Our agency has home health clients scattered throughout the county. A new requirement for Managed Care Services will include Electronic Visit Verification, a tool to help reduce fraud and abuse. For our clients and our nursing, home care aide, and homemaker staff, this will mean staff will only need to document the services provided to these clients once—at the client's home. This service requires internet accessibility and some of our clients live in "dead" areas, places where there is no technology.

Our agency also services people needing access public health programming. We have the capability to accept emailed questions, on-line scheduling for appointments and have state and national links listed on our website. The availability of technology to access such programming is sometimes time critical and if all county residents have access to and availability of connectivity we can have a positive impact on promoting current and correct information to those in need. This can help to decrease misinformation—a leading cause of frustration.

We need to be equitable, ensuring residents have accessibility to the Broadband Intervention. Thank you for your consideration.
