To the Office of the Chief Information Officer of the State of Iowa:

As the Emergency Manager and 911 Coordinator for Cedar County, I can provide solid reasoning as to why Cedar County should be considered as a prime candidate to qualify for a Broadband Intervention Zone.

Cedar County is a largely rural county of 18,505 individuals, bordered by three of the most populous counties in our state. As a rural county, we face certain communications challenges, especially when we consider the need to share emergency preparedness and disaster information with our residents. Many of our communities, especially those unincorporated areas that would be served by a Broadband Intervention Zone, rely on a weekly newspaper as Cedar County is not home to a daily newspaper. Further, there are no television or radio stations operating specifically for Cedar County. The absence of these traditional media sources does make the sharing of emergency preparedness messaging and disaster information difficult; these are messages that need to be shared for the safety and wellbeing of our residents. As part of our response to some of these challenges, Cedar County Emergency Management has implemented a robust and extensive social media presence through many different social media platforms. This social media presence allows us to share information quickly, however, we realize that due to the lack of broadband in some of our communities, this information may not get through to those residents that truly need this information. Having the ability to access broadband ensures that more Cedar County residents have the opportunity and the ability to access critical information during those times where information is key. Without broadband access, our residents can easily miss information and data that may help keep them safe during times of disaster.

Broadband access is also important to many of our agency's missions during disaster response. As an example, our agency has made extensive use of social media mining for damage assessment requirements related to natural disasters. After the Derecho of 2020, social media mining helped us extrapolate the areas in our county with the most significant damages. This analysis then allowed us to focus our response on the areas of Cedar County that needed the most help; without broadband access, it can be difficult (if not impossible) for residents to share information, pictures and damage reports with response agencies.

As the 911 Coordinator for Cedar County, I can assure you that broadband also plays a significant role in telephonic communication within the area. Over the past few years, we've seen a significant number of residents switch from traditional POTS (plain old telephone service, i.e., twisted pair/ copper lines) telephone lines to VoIP service for communication needs. Having a consistent and reliable means of electronic transmission for VoIP calling is not only important, but absolutely critical for communications when a resident needs to dial 911. Quality broadband access provides that strong, consistent and reliable means of support for VoIP communication. On a somewhat related note, as the landscape of medical technology changes, I anticipate that we will see more Cedar County residents using Internet based diagnostic technology in their homes. Remote medical devices (such as cardiac monitoring systems,

blood sugar monitoring devices, fetal monitors, etc.) are largely Internet based, and would benefit from expanded broadband access.

The current and future possibilities of expanded broadband access are truly mindboggling. As we look at those areas of Cedar County that would benefit from being established as a Broadband Intervention Zone, we know that this designation would bring about a positive, significant impact on the lives of those residents. I urge that this application be strongly considered for inclusion in the next broadband grant program.

We reside in Cedar County at 1465 265th St. Since purchasing this property nearly three years ago (it was formerly a commercial business [18 hole golf course and club house] but is now our residence), we have found that obtaining reliable internet coverage is nearly impossible. We have pursued multiple avenues, and have yet to find a viable solution. Our neighbors have found the same to be true. One local provider used by those closest to us is WindStream, but they are unwilling to install at our home due to poor line of sight to their tower located north of us on 240th St (we even installed a 30 foot pole to help with this but to no avail... we also offered our property [which sits as one of the highest elevations in the area] as a spot to host an additional internet tower). Additionally, multiple cellular companies show our address as "unavailable" due to a lack of broadband coverage in the area (Verizon, US Cellular, T-Mobile). We even looked at Starlink, but the waiting list and start up costs were prohibitive. We run our consulting business from our home, and the inability to have internet has made this an additional challenge. Currently we rely on cellular data for limited internet.

We strongly encourage the leadership of Cedar County to pursue any and all opportunities to improve upon and offer better internet coverage for their rural residents.

Several years ago, I asked my, then, land line telephone provider, Iowa Telecom (Windsteam), when fiber optics cable would finally be routed to my residence at 1050 Red Oak Park Road, Tipton, Iowa in Cedar County; I was told “never.”

Today, even small phone providers cannot afford to install internet service to rural residential sites when customers are less than five per mile. I have lived at my present location 51 years. For the last 20 of those years, having access to broadband internet would have greatly enhanced my work life as a writer who must submit copy by internet.

I am not as fortunate as those who accidentally live where fiber optic lines were considered economical. My home is surrounded by tall trees. Therefore, I have resorted over the years to US Cellular Hot Spots, a Verizon Jet Pack, and an invasive cell phone signal booster on my roof with cable line into my home through the exterior wall of my dwelling—all of this, just to achieve minimal service that others take for granted.

Electricity managed to reach every household in decades past when it was new to rural properties. Surely the same effort is now warranted for the equally essential internet service.
