This sub-factor takes into consideration whether Broadband investments in the proposed Geographic Area of Concern will help to facilitate community members engagement in employment, search for employment, and/or develop the requisite skills and knowledge to become employed (e.g., participate in career counseling programs, workforce training programs, as well as gain access to internet websites to search for and apply to jobs).

**Work:**

**Bremer County is primarily an agriculturally driven economy and serves as a rural bedroom community for those looking to live within close proximity to the Waterloo/Cedar Falls and Waverly metros. Given the rural geography, cost of living, and ease of Highway 218 and 63, many workers prefer living outside of the metro and commuting to work within the metro. As such, many of these workers have also come to benefit from the work-from-home model and hybrid working environments. However, reliable and affordable internet connectivity is critical in order to take advantage. Unfortunately, those who live outside of Waverly, Denver, Janesville, Sumner, Tripoli, and Readlyn (the six largest Bremer County cities), lack quality internet services. As stated by the CEO of Butler-Bremer Communications, Andrea Hansen, they are "frequently contacted by individuals just outside of our service area who need the same reliable service our customers benefit from today" for various reasons including work, school, and telemedicine. Reliable internet in many instances can be a deciding factor for those looking to relocate.**

**This accounts for a significant number of individuals who are currently unable to meet the demands of the present working environment and remain productive within the global economy. Moreover, the importance of agriculture in the regions outside of the population centers in Bremer County is critical to the County. Farmers need and require quality internet services as their needs expand and equipment becomes increasingly dependent on being connected to the internet.**

This subfactor takes into consideration whether Broadband investments in the proposed Geographic Area of Concern will help facilitate educational activities. Such education activities may be to acquire knowledge and/or skills, undertaken as part of a person's participation in school, an academic program, extracurricular program, social-emotional development program for students or youths, internship, or professional development program, or in another educational environment.

**Education:**

During the pandemic, the education model shifted from in-person instruction to virtual learning. The needs of students in rural areas became apparent. In Bremer County, all the students outside of Waverly, attend small, rural schools. Many of those school district students did not have sufficient infrastructure to support online learning. To this day, some students are still left trying to navigate their education in today's online world. For example, Steph Campbell-Moeller's letter noted that they need to drive to town just so her daughter is able to complete her schoolwork.

Moreover, many of these students are also served by the local community college, Hawkeye Community College. The College provides high-quality education within close reach of Bremer County. Many of those classes require online learning and engagement. Many other students attend Wartburg College. These types of educational opportunities are crucial for those individuals looking to grow their skills to meet the evolving demands of the economy. Without quality internet, these types of opportunities become out of reach.

This subfactor takes into consideration whether Broadband investments in the proposed Geographic Area of Concern will help facilitate health monitoring services to monitor an individual's health, including with respect to either physical or behavioral health.

**Health Monitoring:**

Bremer County is served by two regional health systems: Waverly Health Center and Community Memorial Hospital. The two hospitals are located in the corners of Bremer County and much of the rural areas identified in the ITQ are over 20 minutes away from access to the hospital and available clinics. As healthcare has evolved to utilize remote/virtual care via telehealth services, these residents are often unable to take advantage of the poor internet services. As indicated in the CFO of Community Memorial Hospital, Dawn Everding's letter of support, as the different types of telehealth services expand, it is becoming increasingly important for those individuals to have internet services so they can effectively and efficiently access these services. Moreover, as it becomes increasingly difficult to find healthcare workers in rural areas such as Bremer County, access to these services becomes even more critical to the health of these residents and will be key to ensuring continued high-quality healthcare in rural Bremer County. For example, Community Memorial Hospital has recently hired a physician that intends to do remote work on days away from the hospital to provide care to his patients.

## **Barriers to Broadband**

### **Barriers to Broadband**

#### **Installation:**

Bremer County is rural and dominated by primarily agricultural farms outside of its cities. Broadband networks are often difficult to build and expand in these rural areas, especially in areas that lack large population centers. Several providers currently exist and provide quality service within Bremer County, but it is difficult to justify investing significantly in these areas that lack large population centers. These areas are separated far enough from population centers that they do not create enough incentives for these providers to invest. Finally, many of these areas are located off main roads, further complicating improvements in connectivity. Outreach efforts have often fallen on deaf ears, but the rural residents of Bremer County want and need internet connectivity for both business and personal reasons. For example, Stephanie Campbell-Moeller's letter of support outlines the multiple steps she has gone through in an attempt to improve her internet connection. Unfortunately, these efforts have gone unheard.

Bremer County has a population of 24,988. Five towns in the County have a population center great than 1,000 (16,568 Total). The remaining 8,420 (33.7%) of the County fall outside a population center of 1,000 people or more. This rurality of Bremer County further complicates the situation for those remaining underserved. With such a significant population in rural areas within a rural county, the need becomes even greater and harder to address for providers who need to invest significant resources to serve them.
