Thanks for the email, as the location that we are looking to expand into with these funds, I am relying on your data that was part of the importing process of the census blocks. I have attached a copy of Exhibit B again showing the blocks that were targeted or not.

However, we were in the planning phases to build out a part of this build this year prior to this grant opportunity, as the customers were all claiming that they could not get 25/3 from any provider, even though the maps said that they could. If I remember right, when I looked at "Connected Nation" maps for part of this, they had listed Mediacom as being there and that they could provide 1GB service. Mediacom has no mainline cable anywhere near these customer (along Sandhill Trail mainly, I have not looked at the entire area). Furthermore, I am not aware of any fixed wireless providers providing service at the 25/3 speeds in this area. I would think that the providers that could would only be the cellular providers (ie Verizon or Us Cellular), even then I am not sure they can get 25/3.

So, to answer the question asked in the email though and to "Certify", I would have to answer the following way:

**Only a portion of this potential project is unserved by 25/3 (in a TSA) and that number comes to 20 across the census blocks that we are building out too. They are the blocks listed on the attachment.**

If we are awarded this money, our original build would expand to pick up more than the 20 that are in the targeted areas. As our original build would connect approximately 60 homes to fiber (capable of providing Gigabit speeds) to the 102 locations that fill out the census block that I have submitted as part of this application. If awarded this grant, we would build to 100% of the locations on this application.

I would further like to thank you and your office for the opportunity to expand our network to pick up more locations than we had originally planned. We have been fielding multiple calls from customer in these locations to supply them better broadband as this pandemic has forced many of the people in this area to work from home, and they have been crippling along mainly using cellular hotspots. Expanding our FTTH network to these blocks will future proof these locations for years to come.

Thank you for submitting a grant application to the State of Iowa Broadband Grants Program - Empower Rural Iowa Initiative (NOFA #003). The Office of the Chief Information Officer (OCIO) requests the following clarification concerning the contents of your application.
