Federal RDOF funding will be used to help construct this project. LTD Broadband has been provisionally awarded funding. Although RDOF funding may not occur until later this year, LTD Broadband will immediately commence permitting and construction with our own funds in addition to NOFA #5 funding.

If this project is not awarded for CARES funding, these areas may wait as long as 6 years before they are serviced by LTD Broadband. The time-sensitive nature of the RDOF buildout would otherwise force LTD Broadband to build denser areas first to comply with the completion percentage milestones that are part of RDOF.
