Mabel Cooperative Telephone Company (Mabel) is proposing to construct a GPON Fiber Network. The fiber architecture will allow the high-speed broadband services required to meet the requirements described in this NOFA. The fiber access electronics will enable the provisioning of individual service offerings of 100/100 Mbps, and will allow for speeds that will ensure the network is future-proof, allowing for telehealth, telework and on-line learning among numerous beneficial economic impacts.

The board has approved this grant application and the funds needed for the build, given there is a 38.05% match. The construction crew and equipment has been researched and Mabel is able to acquire the essential materials and crews to complete the project before the grant deadline.

If the grant is not awarded, the project will be cancelled or delayed by several years. ACAM monies were needed within our study area to achieve fiber build-out and maintenance of the network and some money is also needed to deploy this technology in unfunded ACAM areas of our ILEC territory. Delaying this opportunity would not be in the public interest and grant monies are needed to fulfill the entire project.
