Modern Cooperative Telephone Company (Modern Coop) determined the total eligible infrastructure costs to be \$1,029,000 for the West Rural Parnell FTTP. Modern Coop's Empower Rural Iowa Broadband grant request is 56.18%, \$578,092, of the total eligible infrastructure costs in the proposed area, with 43.82% being self-funded by Modern Coop. Modern Coop is committed to working toward overall community enhancement that includes residents, businesses, and community anchor institutions within the rural areas of Iowa County. Access to high-speed broadband service should be available to every resident regardless of whether they live in town or out in the rural areas. The locations included in Modern Coop's application would be too costly to build without funding assistance. Due to the rural nature and relatively low population density, this project would be difficult to justify without the financial assistance from the Empower Rural Iowa Broadband Grants Program. Therefore, the proposed West Rural Parnell FTTP will likely not move forward as presented without grant assistance.
