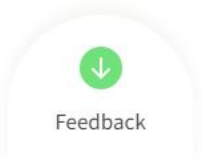

Dear Debra Lucht,

Your entity registration in the System for Award Management (SAM) will expire soon. To be eligible for federal awards, you must have an active SAM registration. It is your responsibility to keep your registration current. If you have existing awards with the government, you must renew your SAM registration annually to ensure continued payments.

SAM is an official website of the U.S. federal government. There is NO FEE to register or maintain your SAM registration.

To renew your registration, follow these instructions:

1. Go to <https://www.sam.gov> and log in
 2. In your Workspace, select the Entity Management link
 3. On the next page, select the entity you want to update, or search for the entity then select it
 4. Select the Action icon to the right that has three vertical dots, then select Update
 5. Complete your registration update by following the on-screen instructions
 6. Select Submit at the very end. You will see a confirmation message on the screen when you submit your renewal.
 7. If you have not previously submitted a notarized letter formally designating the Entity Administrator for your entity, you must do so now. Failure to do so within 60 days of activation may result in the registration no longer being active.
- NOTE: You are not required to provide a notarized letter for a federal entity registration.

HELPFUL TIPS

1. Plan ahead! U.S. registrations must go through Taxpayer Identification Number (TIN) validation. All registrations must go through Commercial and Government Entity (CAGE) Code validation. Together, these processes can take up to 12 business days after you submit your registration. While the average is much faster, allow time for these external processes and begin your renewal now.
2. Get FREE help at <https://www.sam.gov> in the Help section where you will find the full SAM User Guides, Quick Start Guides, Helpful Hints, Webinars, and answers to Frequently Asked Questions.
3. Check your registration status at any time. Go to <https://www.sam.gov> and select Check Registration Status at the bottom of the page. Enter your UEI (DUNS), UEI (SAM) or CAGE Code to quickly check your progress.

You successfully submitted the entity registration for MINBURN TELEPHONE COMPANY / 021694450 / HWQGH18A1Y61 / 5LHY2 in the U.S. federal government's System for Award Management (SAM). This registration record will remain in Submitted status until all external validations are complete.

What happens next?

1. If you provided a Taxpayer Identification Number (TIN), the Internal Revenue Service (IRS) will conduct a validation of your TIN and Taxpayer Name. This step can take two business days. You will get an email from SAM.gov when that review is complete.
2. Your registration will then be sent to the Defense Logistics Agency (DLA) Commercial and Government Entity (CAGE) Code system for assignment or validation of your CAGE Code. This step averages two business days, but the DLA CAGE team can take up to ten business days, or longer, in peak periods. You will get an email from SAM.gov when that review is complete.
3. If the DLA CAGE team has any questions, they will contact the individual you listed as the Government Business Point of Contact (POC) via email. The email will come from a dla.mil address. Please tell your Government Business POC to respond right away to any requests from a dla.mil email. If a timely response is not received, your registration will be returned to SAM and your registration status changed to Work in Progress. You will have to resubmit and provide the requested information to DLA CAGE to continue.
4. You will get an email from SAM.gov when your registration passes these external validations and becomes Active. Until then, use the Check Registration Status link at SAM.gov to see where your registration is in the review process.
5. If you have not previously submitted a notarized letter formally designating the Entity Administrator for your entity, you must do so now. Failure to do so within 60 days of activation may result in the registration no longer being active. NOTE: You are not required to provide a notarized letter for a federal entity registration.
