To whom it may concern;

Southwest Iowa Planning Council, a council of governments and economic development district that serves 8 counties in Southwest Iowa, strongly supports Midwest Data's proposal to extend fiber optic internet to the eligible locations within ITQs 40 and 60 under the current OCIO NOFO #8. Midwest Data is a valued local partner that will be building upon its existing network and doing so in a way that extends broadband internet in an affordable manner.
