To all RFP bidders,

The State evaluation committee has reviewed, evaluated, and scored the proposals received in response to RFP #0722-661-01 issued on behalf of the Department of Public Safety on July 2, 2022, for an Anonymous Reporting Solution. Six (6) proposals were received by the due date and time. The Respondents were:

- Rave Mobile Safety
- Brite Systems
- Catalyst Consulting
- Navigate360, LLC
- ELERTS
- Sandy Hook Promise

In order to be eligible for an award pursuant to this procurement, proposers were required to submit all required documents, pass all Section 4.3 Mandatory Specifications, and receive a minimum 4800 points of a maximum 8000 points on the Section 4.4 Scored Specifications.

Two technical proposals, Brite Systems and Catalyst Consulting, were deemed non-responsive and rejected by the Evaluation Committee. The remaining four proposals were deemed responsive and reviewed by the Committee.

Technical Proposal Scoring

Evaluators reviewed, but did not score, the proposal independently, before meeting as a group to discuss the technical proposal. Evaluators considered the information discussed during the meeting and worked as a group to determine a consensus score. At the end of the Evaluation Committee meetings, technical proposal scoring was finalized.

Cost Proposal Scoring

Cost Proposal pricing was scored based on a ratio of the lowest Cost Proposal versus the cost of each higher priced Cost Proposal. Under this formula, the lowest Cost Proposal receives all of the points assigned to pricing. A proposal twice as expensive as the lowest Cost Proposal would earn half of the available points. Cost Proposal scores are as follows:

If the Awardee fails to execute a contract with the State for any reason, the State, in its sole discretion, may cancel this Notice of Intent to Award, or withdraw the RFP entirely. The State further reserves the right to cancel the Award at any time prior to the execution of a written contract.
