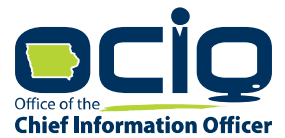

Applicant ***MUST*** acknowledge all boxes to obtain certification:

- Applicant must continue to make 25/3 Broadband available for the entire period the property-tax exemption is granted to maintain tax-exempt status, and may be periodically required to substantiate that applicant continues to provide 25/3 Broadband.
- Upon completion of an installation, applicant must certify to the OCIO that an installation facilitates broadband service at or above 25/3 Broadband, and identify the number of Homes, Schools, and Businesses that have access to 25/3 Broadband in a TSA in which a property-tax exemption is claimed. Additionally, applicant must provide the OCIO with a geographic reference outlining specifically where in a TSA in which a property-tax exemption is claimed 25/3 is available.
- After applicant has certified to the OCIO that an installation facilitates broadband service at or above 25/3 Broadband, the OCIO may conduct field-test audits in accordance with 129 IAC 21.8 in order to ensure compliance with applicable laws, rules, and regulations.
- Upon request by the OCIO, applicant shall be available to provide further information to the OCIO related to its broadband infrastructure for which a property-tax exemption is claimed, or other additional information as may reasonably requested by the OCIO.
